**Interim Measures**

Under rule 94 of the Committee's rules of procedure, the State Party has been requested to take all necessary and effective measures with the Pakistani authorities, including diplomatic and administrative measures, to prevent the authors' removal to Afghanistan, and to ensure the authors' safe accommodation, while the communication is under examination by the Committee. This request does not imply that any decision has been reached on the substance of the matter under consideration.

**Registration of the case**

In accordance with rule 92 of the Committee's rules of procedure, a copy of the communication has been transmitted to the State Party today, with the request that any information or observations in respect of both the question of admissibility and the merits of the communication should reach the Committee no later than 23 July 2026. Any reply from the State Party will be communicated to you in due course to enable you to comment thereon. Please refrain from sending any additional information or comments until then. Given the high number of cases pending consideration with the Committee, please note that we are not in a position to respond to status inquiries.
